COUNT I

On or about August 31, 2019, in the above-entitled Judicial District, ERIKA KOIKE did willfully and unlawfully resist, delay or obstruct a public officer discharging or attempting to discharge any duty of his office or employment, a violation of Section 148(a)(1) of the PENAL CODE of the State of California, a misdemeanor.

COUNT II

On or about July 31, 2019, in the above-entitled Judicial District, ERIKA KOIKE did willfully and unlawfully use force and violence against, a peace officer, a custodial officer, a firefighter, an emergency medical technician, a paramedic, a traffic officer, an animal control officer, then and there engaged in the performance of official duties, when the defendant knew or reasonably should have known that the peace officer, custodial officer, firefighter, emergency medical technician, paramedic, traffic officer, animal control officer was then and there engaged in the performance of duties, thereby violating Section 243(b) of the PENAL CODE of the State of California, a misdemeanor.

City Attorney's Office


